RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE REPLACEMENT OF CARPET FLOOR TILES AT CHECK-IN COUNTER AREA AND PBB AT ILOILO INTERNATIONAL AIRPORT
