RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE REPLACEMENT OF CARPET FLOOR TILES AT CHECK-IN COUNTER AREA AND PBB AT ILOILO INTERNATIONAL AIRPORT



Resolved this 28th day of May 2021 at the Civil Aviation Authority of the Philippines, Iloilo Airport, Cabatuan, Iloilo.


