RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE REPAIR AND MAINTENANCE OF ESCALATORS AND ELEVATORS AT ILOILO INTERNATIONAL AIRPORT
