RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE SUPPLY AND DELIVERY OF ELECTRICAL SUPPLIES FOR THE YEAR 2021 AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, in response to the said advertisement and on the day of the Preliminary Examination of Bids, five (5) bidder submitted their sealed bid proposals;

WHEREAS, upon submission and conduct of Post Qualification Evaluation **IIC ELECTRICAL HARDWARE CONSTRUCTION SUPPLY**, was disqualified due to failure to comply the Bid Bulletin No. 01 dated August 19, 2021 Item C. Warranty of all LED Lights should be at least three (3) years, wherein they indicated one (1) year only and failure to submit the Post Qualification Requirements *Item No. 6 Other appropriate licenses and permits required by law and stated in the BDS* specifically, Certification From Department of Energy (DOE) for IP 65 Street Light, in accordance with Section 23.1(a) (iv) of the Revised Implementing Rules and Regulation (IRR) of the Republic Act (RA) 9184, *"The submission of the Eligibility Documents enumerated in the Section 23.1 of the IRR RA 9184 is a mandatory requirement that must be complied with by the prospective bidders, such that failure to submit any of the documents or submission of an otherwise incomplete or patently insufficient document, will disqualify the bidder based on the non-discretionary "pass/fail" criterion under Section 30.1 of the IRR RA 9184"* and Notice of Disqualification was sent last September 24, 2021;

WHEREAS, Post Qualification Evaluation was conducted for the Second Lowest Calculated Bidder **ILOILO PARAMOUNT INDUSTRIAL AND ELECTRICAL, CO. INC.** last October 5, 2021;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder **ILOILO PARAMOUNT INDUSTRIAL AND ELECTRICAL, CO. INC.** was declared as Lowest Calculated Responsive Bid;

NOW THEREFORE, We, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:


- a) To declare **ILOILO PARAMOUNT INDUSTRIAL AND ELECTRICAL, CO. INC.** as the Supplier with the Lowest Calculated Responsive Bid for the : **SUPPLY AND DELIVERY OF ELECTRICAL SUPPLIES FOR THE YEAR 2021 AT ILOILO INTERNATIONAL AIRPORT** in the bid amount of **ONE MILLION ONE HUNDRED NINETY SIX THOUSAND ONE HUNDRED FIVE PESOS ONLY (₱1,196,105.00)**;


