WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for Supply and Delivery of Office, IT and Janitorial Supplies for the month of August to December 2021 at Iloilo International Airport in the PhilGEPS and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of Two Million Three Hundred Four Thousand Seventy Six Pesos & 72/100 Only (P2,304,076.72);


