RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF IT SUPPLIES FOR FEBRUARY TO APRIL 2021 AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2021-003-01 for the project Supply and Delivery of IT Supplies for February to April 2021 at Hoilo International Airport with Approved Budget for the Contract (ABC) in the amount of Two Hundred Eighteen Thousand Forty Nine Pesos (\$\mathbb{P}\$218,049.00) hereby form the integral part of this resolution.
