RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF TOOLS AND SPARE PARTS OF TOOLS AND VEHICLES AT ILOILO INTERNATIONAL AIRPORT


- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
