Repair And Maintenance of Firetrucks (Oshkosh) At Legazpi Airport - 4th SVP

The Civil Aviation Authority of the Philippines (CAAP), Area Center V, Bicol International Airport intends to apply the estimated amount of Eight Hundred Sixteen Thousand Nine Hundred Sixty Eight Pesos & 25/100 (Php 816,968.25) for the Repair And Maintenance Of Firetrucks (Oshkosh) At Legazpi Airport – 4th SVP project.

The CAAP now requests you to submit price quotation on the item listed below, subject to the Specification and Terms and Conditions provided hereunder.

- 1. All entries must be printed.
- Number of days to complete: Seventy five (75) calendar days.
- 3. Bid must be complete and award will be made on a lump sum basis.
- 4. Price validity shall be for a period of One Hundred Twenty (120) calendar days.
- 5. The following should be submitted together with the quotation:
 - 5.1 Current Mayor's/Business Permit;
 - 5.2 Phil-GEPS Registration Number;
 - 5.3 Valid license and/or certificate of Automotive Mechanic/Technician; and
 - 5.4 Un-amended Sales Literature of the fuel injector with Picture, Brand Name, and Unconditional Statements of specification and compliance issued by the manufacturer.
- 6. Other documentary requirements:
 - 6.1 Omnibus Sworn Statement (see attached format, maybe submitted together with the quotation or before issuance of Notice of Award);
 - 6.2 Latest Income & Business Tax Returns [maybe submitted together with the quotation on or within the deadline indicated in the notice to the bidder with the Lowest Calculated Bid (LCB).]
 - 6.2.1 Latest Income Tax Return (ITR) shall be the ITR for the preceding year, whether calendar or fiscal duly stamped received by the BIR; and
 - 6.2.2. Latest Business Tax Returns shall refer to the Value Added Tax (VAT) or Percentage Tax filed and paid covering the previous six (6) months before the date of Submission, Receipt, Opening & Preliminary Examination of Bids filed through the Electronic Filing & Payment System (EFPS).

- 6.3 Additional Requirements to be submitted before issuance of Notice To Proceed:
 - 6.3.1 Work Schedule:
 - 6.3.2 Manpower Schedule;
 - 6.3.3 Work Method; and
 - 6.3.4 Performance Security.

Quotations not accompanied by current Mayor's/Business Permit, Phil-GEPS Registration Number, valid license and/or certificate of Automotive Mechanic/Technician; and Unamended Sales Literature of the fuel injector with Picture, Brand Name, and Unconditional Statements of specification and compliance issued by the manufacturer shall be automatically disqualified.

Prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery site if the contract is awarded.

Quotations must be delivered to the address below **not later than 25 November 2021 at 2:00 p.m.** at the BAC Office, Ground Floor, Admin Building, Bicol International Airport, Daraga, Albay.

Quotations will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late quotations shall not be accepted.
