EXTENDING THE VALIDITY OF CAAP ISSUED

AIRMEN LICENSES AND CERTIFICATE

In view of the pronouncement of President Rodrigo Roa Duterte based on the Resolution No. 11, Series of 2020 of the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Disease dated 12 March 2020, imposing a 30-day community quarantine in the National Capital Region (NCR) due to Coronavirus Disease 2019 pandemic and the suspension of work in the executive branch, disrupting the normal operations of the Flight Standards Inspectorate Service including processing of airmen licenses and certifications, the Civil Aviation Authority of the Philippines hereby extends the validity period of the following airmen licenses and certificates:

Air Operator Certificate (AOC)

Approved Maintenance Organization Certificate (AMO)

Approved Training Organization Certificate (ATOC)

Agricultural Air Operator Certificate (AAOC)

RPAS Operator Certificate (ROC)

Certificate of Authorization (COA)

Certificate of Airworthiness (CofA)

Certificate of Registration (CofR)

Aircraft Material Distributor Certificate (AMD)

Airline Transport Pilot License (ATPL)

Commercial Helicopter Pilot License (CHPL)

Commercial Pilot License (CPL)

Flight Engineer License (FEL)

Flight Instructor License (FIL)

Flight Operations Officer License (FOO)

Ground Instructor License (GI)

Multi-Crew Pilot License (MCPL)

Private Helicopter Pilot License (PHPL)

Private Pilot License (PPL)

Student Pilot License (SPL)

Student Helicopter Pilot License (SHPL)

Aircraft Mechanic Technician License (AMT)

Aviation Maintenance Specialist License (AMS)
Aeronautical Station Operator License (ASO)
Air Traffic Controller License (ATC)
Air Traffic Safety Electronic Personnel License (ATSEP)
Remotely Piloted Aircraft Controller Certificate
all other certificates being processed by the Flight Standards Inspectorate Service

Only licences and certificates expiring on/or after 15 March 2020 up to the resumption of FSIS normal operations, as determined by the CAAP, will be covered by the extension.

Receiving of applications for initial issuance and/or renewal of the aforementioned certificates/licenses is temporarily suspended. However, pending applications for airmen licenses and certification before the Authority will be processed accordingly.

This Memorandum Circular shall take effect immediately.
