



MEMORANDUM CIRCULAR 25-16

TO : ALL CONCERNED

SUBJECT : CABIN CREW MEMBER LICENSE

DATE : JULY 11, 2016

Effective immediately, the requirements set forth under Memorandum Circular 33-13, series of 2013, with the *Subject: Initial Issuance of Current and Newly-Hired Cabin Crew Member Licensing Procedures*, is hereby **TEMPORARILY SUSPENDED**.

Thus, any person desiring to be a Cabin Crew Member in Philippine-registered aircraft engaged in commercial air transport operations, shall no longer be required to obtain a Cabin Crew Member License, effective 11 July 2016.

In this connection, the processing of all applications for the initial issuance or renewal of a Cabin Crew Member License pending before the Licensing and Certification Department, Flight Standard Inspectorate Service, CAAP, shall also be discontinued.

Furthermore, all previously issued Cabin Crew Member License shall remain valid until the date of expiration provided the license holder maintains the required competence and has a satisfactory report of medical fitness. Likewise, all current and valid Cabin Crew Member License shall be recognized as equivalent to the Cabin Crew Competency Card required to be carried by each cabin crew whenever he/she is on duty and to be presented to CAA inspector when asked for inspection, in accordance with Subsection 8.10.1.24.2 (b) of PCAR Part 8.

Finally, AOC holders shall no longer require Cabin Crew Members to hold and possess a license as a condition for their employment or continued employment.

This Memorandum Circular supersedes, amends, and/or modifies previous circulars, if any, as well as all other issuances or parts thereof which are inconsistent herewith.

This shall take effect immediately from its publication in a newspaper of general circulation in the Philippines. Three (3) copies thereof are directed to be submitted to
