Sealed Bids shall be submitted in a separate envelop for each lot to the Secretariat of Property Disposal Committee, (Attention: Mr. Ernest L. Novis), Supply Division, CAAP Central Office, MIA Road Pasay City not later than 10:00 A.M. on 04 November 2022. The Opening of Bids for Lot A & B shall be conducted at the same day at 10:30 A.M., at the Supply Conference Room, 2nd Floor of CAAP General Services Building, in the presence of the Bidders or their duly authorized representative.

A bid bond shall be imposed on each bidder in the amount equal to Ten Percent (10%) of the floor price. This shall be consequently refunded to unsuccessful bidders after completion of the bidding process while the bid bond of the winning bidder shall form part of the intended full payment. Bidders can purchase bid documents at Three Hundred Pesos (Php 300.00) for each lot at Supply Division to be paid at CAAP Cashiering Division. It is agreed that the winning bidder shall claim all items within 15 working days from the date of full payment of his bid, otherwise the award shall cancelled.
