RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE REPAIR OF POTHOLES ON RUNWAY ASPHALT AT ILOILO INTERNATIONAL AIRPORT
