RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF PVC CARD FOR CSIS RAAB PRODUCTION FOR CY 2023 OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BDC 2023-006-01 for the project Supply and Delivery of PVC Card for CSIS RAAB Production for CY 2023 of Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Eighty Five Thousand Two Hundred Pesos (P 85,200.00) hereby form the integral part of this resolution. WHEREAS, (1) Request for Quotations (RFQ) was forwarded to exclusive supplier;

WHEREAS, Acknowledgement Receipt is attached as proof that copy of Request for Quotation (RFO) was distributed;

WHEREAS, exclusive supplier submitted their quotation;

WHEREAS, during the Bid Opening last October 23, 2023, AZITSOROG INC., was declared Single Calculated Bid with the Bid amount of Eighty Four Thousand Eight Hundred Sixty Five Pesos (P 84,865.00) and was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
