**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL FOR FOOD PROVISION IN RELATION TO
THE CONDUCT OF FULL SCALE EMERGENCY EXERCISE AT ILOILO
INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-035-01 for the project **Food Provision in Relation to the Conduct of Full Scale Emergency Exercise at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Forty Nine Thousand Eight Hundred Forty Pesos (P 249,840.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last September 15, 2023, **MAMBA BAR AND RESTAURANT** was declared Single Calculated Bid with the Bid amount of **Two Hundred Forty Two Thousand Two Hundred Pesos (P 242,200.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

NOW THEREFORE, the Members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:
