



BAC Resolution No. BSVP 2023-036-02

**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL FOR EQUIPMENT RENTALS AND
CONSUMABLES IN RELATION TO THE CONDUCT OF FULL SCALE
EMERGENCY EXERCISE AT ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-036-01 for the project **Equipment Rentals and Consumables in Relation to the Conduct of Full Scale Emergency Exercise at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Fifty Five Thousand Two Hundred Seventy Nine Pesos & 25/100 (₱ 255,279.25)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last September 15, 2023, **ILOILO FABRICATION SPECIALIST INC.** was declared Single Calculated Bid with the Bid amount of **Two Hundred Fifty Five Thousand Pesos (₱ 255,000.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, **ILOILO FABRICATION SPECIALIST INC.** was found to be the Single Calculated Responsive Quotation;

NOW THEREFORE, the Members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare, **ILOILO FABRICATION SPECIALIST INC.** as the Supplier with the Single Calculated Responsive Quotation **Equipment Rentals and Consumables in Relation to the Conduct of Full Scale Emergency Exercise at Iloilo International**


