**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL FOR VIDEO/PHOTO DOCUMENTATION IN
RELATION TO THE CONDUCT OF FULL SCALE EMERGENCY EXERCISE AT
ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-037-01 for the project **Video/Photo Documentation in Relation to the Conduct of Full Scale Emergency Exercise at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Sixty Seven Thousand Five Hundred Pesos (₱ 67,500.00)** hereby form the integral part of this resolution. WHEREAS, during the Bid Opening last September 15, 2023, **MYRELL HECHANOVA PORTRAIT PHOTOGRAPHY** was declared Single Calculated Bid with the Bid amount of **Sixty Thousand Pesos (₱ 60,000.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:


