RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF ONE HUNDRED THIRTY SIX (136) PCS 7AH, 12V INDUSTRIAL TYPE VRLA BATTERIES FOR TWO (2) EATON 9PX-11000 AND ONE (1) UNIT SOCOMEC 20KVA UPS FOR ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-040-02 for the project Supply and Delivery of One Hundred Thirty Six (136) Pcs 7AH, 12V Industrial Type VRLA Batteries for Two (2) Eaton 9PX-11000 and One (1) Unit Socomec 20KVA UPS for Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Two Hundred Seventy Two Thousand Pesos (P 272,000.00) hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last October 17, 2023, UNITED A ONE ELECTROMECH CORPORATION was declared Single Calculated Bid with the Bid amount of One Hundred Seventy Seven Thousand Twenty Three Pesos & 68/100 (P 177,023.68);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, UNITED A ONE ELECTROMECH CORPORATION was found to be the Single Calculated Responsive Quotation;

NOW THEREFORE, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare, UNITED A ONE ELECTROMECH CORPORATION as the Supplier with the Single Calculated Responsive Quotation for the project Supply and Delivery of One Hundred Thirty Six (136) Pcs 7AH, 12V Industrial Type VRLA Batteries for Two (2) Eaton 9PX-11000 and One (1) Unit Socomec 20KVA UPS for Iloilo International Airport in the bid amount of One Hundred Seventy Seven Thousand Twenty Three Pesos & 68/100 (P 177,023.68);
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
