**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION  
 AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OFFICE AND  
 IT SUPPLIES OF CAAP - CATICLAN AIRPORT**

**WHEREAS**, BAC Resolution No. BSVP 2023-042-01 for the project **Supply and Delivery Office and IT Supplies of CAAP - Caticlan Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Fifty Nine Thousand One Hundred Twenty Eight Pesos & 34/100 (₱ 159,128.34)** hereby form the integral part of this resolution. **WHEREAS**, (3) Request for Quotations (RFQ) were distributed to different suppliers;

**WHEREAS**, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

**WHEREAS**, Two (2) interested supplier submitted their sealed quotations;

**WHEREAS**, during the Bid Opening last October 31, 2023, **ALSTAR MERCHANDISE** was declared Lowest Calculated Bid with the Bid amount of **One Hundred Forty Nine Thousand Three Hundred One Pesos (₱ 149,301.00)**;
