RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF ELECTRICAL AND OTHER SUPPLIES FOR CY 2023 OF CAAP-CATICLAN AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-043-02 for the project Supply and Delivery of Electrical and Other Supplies for CY 2023 of CAAP-Caticlan Airport with Approved Budget for the Contract (ABC) in the amount of Seventy Four Thousand Five Hundred Seventeen Pesos & 71/100 (P 74,517.71) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Ouotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last October 31, 2023, E.I. INDUSTRIAL EQUIPMENT TRADING was declared Single Calculated Bid with the Bid amount of Seventy One Thousand Six Hundred Ninety Nine Pesos (\$\mathbb{P}\$ 71,699.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
