## RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF SEMI-EXPENDABLE SUPPLIES FOR CY 2023 OF CAAP-CATICLAN AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-044-01 for the project Supply and Delivery of Semi-Expendable Supplies for CY 2023 of CAAP-Caticlan Airport with Approved Budget for the Contract (ABC) in the amount of Twenty Five Thousand Pesos (P 25,000.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last October 10, 2023, E.I. INDUSTRIAL EQUIPMENT TRADING was declared Single Calculated Bid with the Bid amount of Twenty Five Thousand Pesos (\$\mathbb{P}\$ 25,000.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, E.I. INDUSTRIAL EQUIPMENT TRADING was found to be the Single Calculated Responsive Quotation;

NOW THEREFORE, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:
