**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION

WHEREAS, BAC Resolution No. BSVP 2023-047-01 for the project **Supply and Delivery of Tank Hydro Test and Refill SCBA of ARFF at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Ten Thousand Nine Hundred Twenty Pesos (₱ 10,920.00)** hereby form the integral part of this resolution. WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last October 02, 2023, **FAR EAST SCUBA INSTITUTE INC.** was declared Single Calculated Bid with the Bid amount of **Ten Thousand Seven Hundred Twenty Five Pesos (₱ 10,725.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
