



BAC Resolution No. BSVP 2023-048-02

**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF
COMPUTER SET, LAPTOP AND PORTABLE SCANNER FOR FY 2023 AT ILOILO
INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-048-01 for the project **Supply and Delivery of Computer Set, Laptop and Portable Scanner for FY 2023 at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Three Hundred Twenty Thousand Pesos (P 320,000.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (5) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, five (5) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last October 09, 2023, **CYBER LINK COMPU SALES** was declared Lowest Calculated Bid with the Bid amount of **Two Hundred Sixty Three Thousand Six Hundred Pesos (P 263,600.00)**;

WHEREAS, bid submitted by the following bidders during bid opening were **DISQUALIFIED** due to:

a) **HYW IT DISTRIBUTION**: *non-compliance to specification of Item No. 3: Laptop, required is "Display 15.6 inch FHD (1920x1080) IPS 300 nits Anti-glare", bidder offered "14.0" display with IPS technology, Full HD 1920x1080 resolution, high brightness Acer ComfyView LED-backlit TFT LCD, 16:9 aspect ratio, 45% NTSC color gamut, Wide viewing angle up to 170 degrees, Mercury free, Environment friendly";*

b) **MASANGKAY COMPUTER CENTER**: failure to attached the **Annual Income Tax Return, Omnibus Sworn Statement and Special Power of Attorney for Sole Proprietorship/Secretary Certificate for Corporation or Cooperative** as stated in the Request for Quotation; and

c) **NUNTIUS ELECTRONICS INC.,**: non-compliance of RFQ BSVP 2023-048 Terms and Conditions Item No. 3: *"Bidders must quote for all the items."*

In Section 30.1. of the 2016 revised IRR of RA No.9184 *"The BAC shall open the first bid envelopes in public to determine each bidder's compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement.*



In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed.";

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, **CYBER LINK COMPU SALES** was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

WHEREAS, during the Post Qualification of Documents last October 16, 2023, Bids and Award Committee (BAC) verified the documents and **CYBER LINK COMPU SALES** complied with the requirements as stated in the Notice for Post Qualification Evaluation;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, **CYBER LINK COMPU SALES** was found to be the Lowest Calculated Responsive Quotation;

NOW THEREFORE, the Members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare, **CYBER LINK COMPU SALES** as the Supplier with the Lowest Calculated Responsive Quotation for the project **Supply and Delivery of Computer Set, Laptop and Portable Scanner for FY 2023 at Iloilo International Airport** in the bid amount of **Two Hundred Sixty Three Thousand Six Hundred Pesos (₱ 263,600.00)**;
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
