**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION
 AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF 15 UNITS
 LED FLOOD LIGHTS (20W) FOR WIND CONE AT RUNWAY 02-20 OF ILOILO
 INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-049-01 for the project **Supply and Delivery of 15 Units LED Flood Lights (20W) for Wind Cone at Runway 02-20 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Eleven Thousand Nine Hundred Twenty Five Pesos (P 11,925.00)** hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Three (3) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last October 17, 2023, **AEP SYSTEMS INTEGRATION INC.** was declared Lowest Calculated Bid with the Bid amount of **Nine Thousand Three Hundred Sixty Pesos (P 9,360.00)**;

WHEREAS, bid submitted by **ILOILO PARAMOUNT INDUSTRIAL & ELECTRICAL CO., INC.**, has been disqualified during the bid opening due to: failure to attached the *Business Permit, PhilGEPS Certification of Registration and Special Power of Attorney (for Sole Proprietorship) or Secretary Certificate (for Corporation or Cooperative)* as stated in the Request for Quotation;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
