BAC Resolution No. BSVP 2023-052-02

RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL SUPPLY AND DELIVERY OF GARDENING SUPPLIES FOR FY 2023 OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-052-02 for the project Supply and Delivery of Gardening Supplies for FY 2023 of Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of One Hundred Thirty Two Thousand One Hundred Five Pesos & 50/100 (P 132,105.50) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS. One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last November 6, 2023, MCARV OFFICE AND SCHOOL SUPPLY AND EQUIPMENT was declared Single Calculated Bid with the Bid amount of One Hundred Thirty One Thousand Four Hundred Fifty Six Pesos (₱ 131,456.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, MCARV OFFICE AND SCHOOL SUPPLY AND EQUIPMENT was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

WHEREAS, during the Post Qualification of Documents last November 10, 2023, Bids and Award Committee (BAC) verified the documents and MCARV OFFICE AND SCHOOL SUPPLY AND EQUIPMENT complied with the requirements as stated in the Notice for Post Qualification Evaluation;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, MCARV OFFICE AND SCHOOL SUPPLY AND EQUIPMENT was found to be the Single Calculated Responsive Quotation;

WHEREAS, in Section 34.4 of the 2016 revised IRR of RA No.9184: "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower."

NOW THEREFORE, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare, MCARV OFFICE AND SCHOOL SUPPLY AND EQUIPMENT as the Supplier with the Single Calculated Responsive Quotation for the project Supply and Delivery of Gardening Supplies for FY 2023 of Iloilo International Airport in the bid amount of One Hundred Thirty One Thousand Four Hundred Fifty Six Pesos (P 131,456.00);
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
