- 1. Bidders must provide correct and accurate information required in this form.
- 2. Only authorized representative shall be allowed to sign the Request For Quotation in behalf of the owner/corporation.
- 3. Bidders must quote for all the items.
- 4. Price quotation/s must be valid for a period of Thirty (30) calendar days from the date of submission.
- 5. Price quotation/s, to be denominated in Philippine peso shall include all taxes, duties and/or levies payable.
- 6. Bidders must indicate Expiry Date of Drugs and Medicines must not be earlier than 2025. Should the contractor provide an earlier date, the end-user may request for replacement.
- 7. Bidder must have the following:
- · License to Operate issued by the Food and Drug Administration (FDA) in accordance to RA 9711 "Food and Drug Administration (FDA) Act of 2009" and related issuances.
- 8. Quotations exceeding the Approved Budget for the Contract shall be rejected.
- 9. Award of contract shall be made to the lowest quotation (for goods and infrastructure) or, the highest rated offer (for consulting services) which complies with the minimum technical specifications and other terms and conditions stated herein.
