

INVITATION FOR NEGOTIATED PROCUREMENT DUE TO TWO-FAILED BIDDINGS

CILO 2021-004 REPAIR AND MAINTENANCE OF AUTOMATIC SLIDING DOOR AT ILOILO INTERNATIONAL AIRPORT

1. The **Civil Aviation Authority of the Philippines Iloilo International Airport** intends to procure **Repair and Maintenance of Automatic Sliding Door at Iloilo International Airport** with the Approved Budget for the Contract (ABC) of **Four Hundred Twenty Four Thousand Three Hundred Seventy Eight Pesos & 70/100 (P 424,378.70)**.
2. The **CAAP Iloilo International Airport**, through its Bids and Award Committee (BAC), now invites technically, legally, and financially capable suppliers for the said **Repair and Maintenance of Automatic Sliding Door at Iloilo International Airport**.
3. The procurement procedure for this requirement is Negotiated Procurement pursuant to Section 53.1 of the Revised Implementing Rules and Regulations (IRR) of the Republic Act (R.A.) No. 9184, otherwise known as the “Government Procurement Reform Act”, including Annex H thereof.

The BAC will engage in negotiations with a sufficient number of suppliers to ensure effective completion. **The selection of the successful offer shall be based on the best and final offer that will be submitted on the specified date shown below, which would meet the minimum technical specifications required.**
