The **Civil Aviation Authority of the Philippines Iloilo International Airport** intends to procure **Repair of Ceiling of Mabuhay Lounge at PTB at Iloilo International Airport** with the Approved Budget for the Contract (ABC) of **One Hundred Ten Thousand Three Hundred Thirty One Pesos & 86/100 (P 110,331.86)**.
2. The **CAAP Iloilo International Airport**, through its Bids and Award Committee (BAC), now invites technically, legally, and financially capable suppliers for the said **Repair of Ceiling of Mabuhay Lounge at PTB at Iloilo International Airport**.
