## RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE REPAIR AND MAINTENANCE OF BMS, CMS AND ACS AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for the Repair and Maintenance of BMS, CMS and ACS at Iloilo International Airport in the Philippines and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of One Million One Hundred Seventy Thousand Four Hundred Pesos (P 1,170,400.00);

WHEREAS, in response to the said advertisement, one (1) interested bidder submitted its letter of intent and bought the bidding documents;
