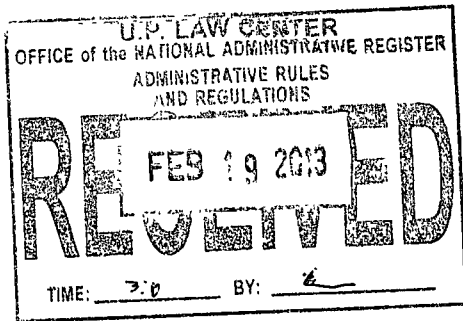

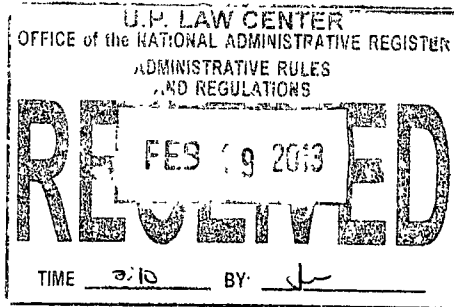

Further, aircraft/s not listed in this MC, ***ALL Aircraft Owner/Lessee, who are responsible for the continuing registration of their aircraft, are finally enjoined to comply with CAAP Memorandum Circular Nos. 25-12 Series of 2012 and 27-12 Series of 2012 on Aircraft Registration and its Supplemental Regulation*** duly published with the Manila Standard Today on 16 November 2012 and 29 November 2012, respectively.

Within fifteen (15) calendar days upon single publication in a newspaper of general circulation of this Memorandum Circular, concerned aircraft owner/lessee may file "Affidavit of Discrepancy" involving data/list given, and the public is enjoined to submit/give any information involving RP-registered aircraft. Thereafter, any aircraft not listed/included in the Final List shall not be issued Flight Clearance/Plan, except those that may be the subject of affidavit of discrepancy and or listing, as the case may be.

The Assistant Director General II, FSIS, together with the Chief, Engineering and Aircraft Registration, is hereby authorized to continue preparing and issuing new 'C of R' and complete 'Aircraft Registry' provided the following conditions are present:

- 1. The old C of R is current;**
- 2. The renewal process has been complied with, and the fees are fully paid; and**
- 3. That, upon actual verification, there is/are no pending issue/s.**

Moreover, the process of revalidation for ALL Philippine registered aircraft shall continue, and the validity of C of R and "Aircraft Registry" for each aircraft shall depend on the finding whether there is/are no "issue/s" found based on the actual and physical revalidation and the consequent enforcement taken. Thus, CAAP reserves the right to revoke 'C of R' and "Aircraft Registry" issued.


