CONDUCT OF PILOT SKILL TEST FOR INSTRUMENT
RATING (IR) USING SYNTHETIC FLIGHT TRAINER (SFT)

SUPPLEMENTAL PROCEDURE TO PEL MANUAL:

"PEL MANUAL ver. 2011, 10.6.3 SKILL TEST (ST) FOR INSTRUMENT RATING (IR) CHECKS

PROCEDURES

1. ALL Skill Tests (ST) for pilots applying for Private Pilot Licenses (PPL) and Commercial Pilot Licenses (CPL) requiring additional Instrument Rating (IR) shall be performed using a Synthetic Flight Trainer (SFT);
2. The ST shall be performed, with the proper radio phraseology and appropriate callouts, simulating the flight is an actual IR flight;
3. The Pilot Inspector (PI) may provide emergencies to the pilot during the conduct of the said test;
4. The PI shall accomplish an appropriate grade slip forms for the check;
5. A printed flight profile report from the SFT shall be attached to the pilot's application for license.
6. The said flight profile shall be attached to the grade slip and shall form part of the pilot's license records.




