**2.6.3.3 AMS RATINGS**




- (b) At no instance shall an AMS license be issued a *Specialized Services* rating in which the AMO has not been issued.

- (6) For AMS Specialized Services ratings, be specially qualified to perform maintenance on aircraft or components thereof, appropriate to the job for which he/she was employed.
- (7) For AMS Specialized Services ratings, be employed for a specific job requiring those special qualifications by a approved maintenance organization certificated under Part 6 allowed by its operating certificate and approved specific operating provisions to provide maintenance, preventive maintenance or modifications to aircraft; and
- (8) For AMS Specialized Services ratings, be recommended by his employer, to the satisfaction of the Authority, as able to satisfactorily maintain aircraft or components, appropriate to the job for which he is employed;

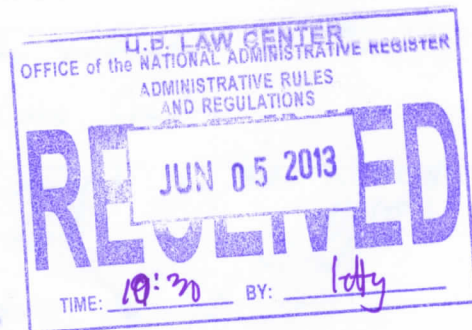
