
**SUBJECT: PER DIEMS FOR LOCAL TRAVEL OF INSPECTORS**

**TO: ALL LOCAL AIRCRAFT OPERATORS/INSPECTORS**

Effective SEP 02 2013, in the exigency of the service and in accordance with the mandate of CAAP to ensure safety of aircraft operation, inspectors shall be paid the following per diems for local travels in accordance with UNDP Daily Subsistence Allowance (DSA) rates as adjusted based on the International Civil Service Commission's DSA Circular Report as of September 2013.



- The applied UNDP rates shall only be given to inspectors conducting all audits, inspections and clarification of air operators, training organizations, maintenance organization, aerodrome operators and other CAAP regulated aviation organizations.
- Travel related expense such as food and accommodations for the inspector/s are included in the DSA/UNDP.
- Per Diem charging will be in effect if the travel is outside the 50km radius from the last city of Metro Manila.
- For Foreign Travels, you may refer to [WWW.UNDP.ORG.PH](http://WWW.UNDP.ORG.PH) for updated rates of per diems as per country of travel.
- Charging of the UNDP/DSA will start upon arrival of the inspector to the site of inspection and end after the inspection.
- This Memorandum Circular shall be applicable only to the conduct of activities mentioned above which are chargeable to CAAP regulated aviation organizations and billed by CAAP Finance Department accordingly.
