- 5. Quotations exceeding the Approved Budget for the Contract shall be rejected.
- In case of two or more bidders are determined to have submitted the Lowest Calculated
 Quotation/Lowest Calculated and Responsive Quotation, CAAP Area Center III shall adopt
 and employ "draw lots" as the tie-breaking method to finally determine the single winning
 provider in accordance with GPPB Circular 06-2005.
- Award of contract shall be made to the lowest quotation which complies with the technical specifications, requirements and other terms and conditions stated herein.
- 8. The item/s shall be delivered according to the accepted offer of the bidder.
- Item/s delivered shall be inspected on the scheduled date and time of the CAAP Area Center III. The delivery of the item/s shall be acknowledged upon the delivery to confirm compliance with the technical specifications
