**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF DRUGS,
MEDICINES AND MEDICAL SUPPLIES FOR CY 2023 OF CAAP-CATICLAN
AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-045-03 for the project **Supply and Delivery of Drugs, Medicines and Medical Supplies for CY 2023 of CAAP-Caticlan Airport** with Approved Budget for the Contract (ABC) in the amount of **Thirty Four Thousand Eight Hundred Fifty Seven Pesos & 90/100 (₱ 34,857.90)** for hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last November 20, 2023, **ECGA MEDICAL EQUIPMENT AND SUPPLIES TRADING** was declared Single Calculated Bid with the Bid amount of **Thirty Four Thousand Seven Hundred Thirty Two Pesos (₱ 34,732.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
