**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF
ADDITIONAL MEDICAL SUPPLIES FOR 2023 OF ILOILO INTERNATIONAL
AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-053-01 for the project **Supply and Delivery of Additional Medical Supplies for 2023 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Three Hundred Sixty Four Thousand Seven Hundred Fifty Pesos (P 364,750.00)** for hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Two (2) interested suppliers submitted their sealed quotations;

WHEREAS, during the Bid Opening last November 07, 2023, **ECGA MEDICAL EQUIPMENT AND SUPPLIES TRADING** was declared Lowest Calculated Bid with the Bid amount of **Two Hundred Fifty Thousand Pesos (P 250,000.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
