**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL OF PURCHASE OF VEHICLE STICKERS FOR
2024 OF ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-057-01 for the project **Purchase of Vehicle Stickers for 2024 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Thirty One Thousand Nine Hundred Pesos (P 31,900.00)** hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last November 20, 2023, **STRATEGIC SUPPLIES AND SAFETY GEARS TRADING** was declared Single Calculated Bid with the Bid amount of **Thirty One Thousand Four Hundred Twenty Five Pesos (P 31,425.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
