



**BAC Resolution No. BSVP 2023-059-02**

**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION  
 AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF  
 ELECTRICAL & CARPENTRY SUPPLIES FOR 2023 OF ILOILO INTERNATIONAL  
 AIRPORT**

**WHEREAS**, BAC Resolution No. BSVP 2023-059-01 for the project **Supply and Delivery of Electrical & Carpentry Supplies for 2023 of Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of One Hundred Forty Four Thousand One Hundred Nineteen Pesos & 15/100 (P 144,119.15)** for hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

**WHEREAS**, (3) Request for Quotations (RFQ) were distributed to different suppliers;

**WHEREAS**, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

**WHEREAS**, One (1) interested supplier submitted its sealed quotation;

**WHEREAS**, during the Bid Opening last November 22, 2023, **IIC ELECTRICAL HARDWARE CONSTRUCTION SUPPLY** was declared Single Calculated Bid with the Bid amount of **One Hundred Forty Three Thousand Five Hundred Ninety Nine Pesos (P 143,599.00)**;

**WHEREAS**, the price quotation of the bidder was found to be substantially compliant:

**WHEREAS**, **IIC ELECTRICAL HARDWARE CONSTRUCTION SUPPLY** was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

**WHEREAS**, during the Post Qualification of Documents last December 1, 2023, Bids and Award Committee (BAC) verified the documents and **IIC ELECTRICAL HARDWARE CONSTRUCTION SUPPLY** complied with the requirements as stated in the Notice for Post Qualification Evaluation;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, **IIC ELECTRICAL**



**WHEREAS**, in Section 34.4 of the 2016 revised IRR of RA No.9184: *“If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower.”*

**NOW THEREFORE**, the Members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare, **IIC ELECTRICAL HARDWARE CONSTRUCTION SUPPLY** as the Supplier with the Single Calculated Responsive Quotation for the project **Supply and Delivery of Electrical & Carpentry Supplies for 2023 of Iloilo International Airport** in the bid amount of **One Hundred Forty Three Thousand Five Hundred Ninety Nine Pesos (P 143,599.00)**;
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
