**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION

**WHEREAS**, BAC Resolution No. BSVP 2023-062-01 for the project **Supply and Delivery of Malasakit Distribution Food Pack for Christmas 2023 at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Thirty Nine Thousand Four Hundred Eighty Pesos (₱39,480.00)** for hereby form the integral part of this resolution. **WHEREAS**, during the Bid Opening last December 11, 2023, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Single Calculated Bid with the Bid amount of **Thirty Nine Thousand Four Hundred Eighty Pesos (₱39,480.00)**;
