**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND
RECOMMENDING APPROVAL FOR THE REMOVAL OF RUBBER DEPOSITS
AT ILOILO INTERNATIONAL AIRPORT**

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for the **Removal of Rubber Deposits at Iloilo International Airport** in the PhilGEPS and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of **Four Million Eight Hundred Eighty Nine Thousand Five Hundred Seventy Four Pesos & 91/100 (₱4,889,574.91)**;

WHEREAS, in response to the said advertisement, one (1) interested bidder submitted its letter of intent and bought the bidding documents;

WHEREAS, on the day of the Preliminary Examination of Bids, one (1) bidder submitted its sealed bid proposals;

WHEREAS, during the Bid Opening last November 7, 2023, **OLONGAPO MAINTENANCE SERVICES, INC.** was declared Single Calculated Bid with the Bid amount **Four Million Eight Hundred Eighty Thousand Six Hundred Sixty Pesos & 38/100 (₱ 4,880,660.38)**;
