This refers to the Competitive Bidding for the contract **“CONSTRUCTION OF CSIS OFFICE AT GENSAN AIRPORT”** conducted by the Civil Aviation Authority of the Philippines - Area XI, the Procuring Entity.

We are pleased to inform you that the above-stated contract is hereby **awarded in favor of CRF CONSTRUCTION, INC. being the bidder with the Single Calculated Responsive Bid (SCRB) in the amount of TWO MILLION SIXTY THOUSAND NINE HUNDRED THREE PESOS AND FORTY-THREE CENTAVOS (22/100) ONLY (₱ 2,060,903.43).**

You are hereby required to formally enter into contract with the herein Procuring Entity **within ten (10) calendar days** from receipt of this notice and submit any one (1) of the following documents within the same **10 CD** period for this purpose:

- a. Cash or cashier's/manager's check issued by a Universal or Commercial Bank – **Ten Percent (10%) of the Total Contract Price**
- b. Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank – **Ten percent (10%) of the Total Price**
- c. Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security – **Thirty Percent (30%) of the Total Contract Price**

The performance security shall be posted in favor of the Procuring Entity and shall contain the conditions prescribed by R.A. 9184 and its implementing rules and regulations, as amended. Failure to enter into the said contract or provide the required Performance Security shall disqualify the bid of **CRF CONSTRUCTION, INC.** and render this notice canceled.

In addition to above-mentioned requirement, you shall also submit the following **upon contract signing**:

1. Occupational Safety and Health Program approved by **DOLE Region 12**; and
2. Program of Works; and the following must also be submitted **before the start of the**

work period:

1. Construction schedule and S-curve;
2. Construction methods; and
3. Equipment utilization schedule.

As you post the performance security and other documents, please include a transmittal to indicate the receipt date.
