Procurement Of Purified Drinking Water For The Use Of CAAP-Bicol International Airport For CY 2024 - EPA - 2nd SVP

The Civil Aviation Authority of the Philippines (CAAP) intends to apply the estimated amount of Two Hundred Thirty Nine Thousand Pesos & 35/100 (Php 239,000.00) for the Procurement Of Purified Drinking Water For The Use Of CAAP-Bicol International Airport For CY 2024 - EPA - 2nd SVP project.

The CAAP now requests you to submit price quotation on the item listed below, subject to the Specification and Terms and Conditions provided hereunder.

All entries must be printed.

- 2. Number of days to complete: From 01 January 2024 or upon issuance of Notice To Proceed up to 31 December 2024 or until 7,800 containers of purified drinking water (@ 5 gallons/container) has been delivered whichever comes first, and subject to extension if and when necessary.
- 3. Bid must be complete and award will be made on a lump sum basis. 4. Price validity shall be for a period of thirty (30) calendar days.
- 5. The following should be submitted together with the quotation:
  - - 5.1 Current Mayor's Permit;
    - 5.2 Phil-GEPS Registration Number; and
    - 5.3 Brochure/picture indicating brand name of the purified drinking water.
- 6. Other documentary requirements:
  - 6.1 Omnibus Sworn Statement (see attached format, maybe submitted together with the quotation or before issuance of Notice of Award.

Quotations not accompanied by Current Mayor's/Business Permit, Phil-GEPS Registration Number; and Brochure/picture indicating brand name of the purified drinking water shall be automatically disqualified.

Your prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery sites if the contract is awarded. Quotations must be delivered to the Civil Aviation Authority of the Philippines, Area Center V not later 2:00 p.m. on 27 December 2023 at its physical address at the BAC Office, Ground Floor Admin Bldg., Bicol International Airport, Daraga, Albay. Quotations will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Online submission is not allowed and late submission shall not be accepted.

All quotations together with the required documents should be placed in a sealed envelope marked Procurement Of Purified Drinking Water For The Use Of CAAP-Bicol International Airport For CY 2024 – EPA – 2<sup>nd</sup> SVP.
