| 1 | In this regard, may we request the technical specifications required for the materials/equipment to be the same as the description/specifications in the BOQ given that description in the BOQ already provides the specifications of materials/equipment? | The end-user accepts the request of the bidder to follow the specifications stated in the BOQ for the materials/equipment to be provided in this Project. However, we encourage the bidder to submit brochures and/or layout plans showing conformity to the standards as evidence/proof of compliance. |
| 2 | Under Special Conditions of Contract GCC Clause 5.1, the project has a total of 2-year warranty period. Please confirm that the bulbs of the runway edge fixtures cannot be applied/included in the warranty period since the bulbs are considered as consumable items. | The 2-year warranty period would only apply to non-consumables items such as runway edge lighting fixtures, transformers, CCR, and circuit breakers). It does not apply to consumables items. |
| 3 | What & how many key personnel/manpower is required? | The end-user only requires the bidder to submit as evidence of compliance the list of its qualified personnel and electrical engineer with their relevant AGL working experience with at least three (3) years' work experience. |
| 4 | What are the allowable working hours for the project? | The number of working hours may be discussed/decided in the method of working plan and must be approved by the aerodrome operator and/or the ANS implementing department. |
| 5 | 60 Calendar Days is not enough for the completion of the works due to items being imported from overseas countries. Would it be possible to extend the duration to 180 Calendar Days for the completion of works? | The end-user accepts the request of the bidder to extend the completion of works but only for within 150 Calendar Days. |
| 6 | All the previous tenders in CAAP require installation of AGL systems require a PCAB license for Navigational Facilities whether it is procurement of infrastructure or Goods. We would like to clarify if a PCAB license for Navigational Facilities must be submitted together with the bid? | The end-user does not require the bidder to possess a PCAB License (Navigational Facility) for this Project, however they should meet the SLCC requirements as stated in the ITB Item 5.3 |
| 7 | Are we required to submit during bid submission the Certificate of After Sales support for at least 10 years? | The bidder may submit the Certificate of After Sales Support of 10 years upon completion of works. |
| 8 | May we request a copy of reference drawing for the project? | A copy of reference drawing will be emailed as per request. |
