**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION

WHEREAS, BAC Resolution No. BSVP 2023-031-07 for the project **Supply and Delivery of Box Fan to be used at Control Tower Cab Room of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Eight Thousand Three Hundred Pesos (₱ 8,300.00)** hereby form the integral part of this resolution. WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last December 19, 2023, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Single Calculated Bid with the Bid amount of **Eight Thousand Three Hundred Pesos (₱ 8,300.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
