## RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR ILOILO TEAM BUILDING 2023 OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-040-02 for the project Iloilo Team Building 2023 of Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Two Hundred Sixty Two Thousand Five Hundred Pesos (₱ 262,500.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

**WHEREAS**, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last October 27, 2023, BEARLAND PARADISE RESORT was declared Single Calculated Bid with the Bid amount of Two Hundred Sixty Two Thousand Pesos (\$\mathbb{P}\$ 262,000.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
