WHEREAS, BAC Resolution No. BSVP 2023-040-02 for the project **Iloilo Team Building 2023 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Sixty Two Thousand Five Hundred Pesos (₱ 262,500.00)** hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last October 27, 2023, **BEARLAND PARADISE RESORT** was declared Single Calculated Bid with the Bid amount of **Two Hundred Sixty Two Thousand Pesos (₱ 262,000.00)**;
