**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION

WHEREAS, BAC Resolution No. BSVP 2023-040-02 for the project **Team Building Activity FY 2023 of Godofredo P. Ramos Airport** with Approved Budget for the Contract (ABC) in the amount of **Thirty Five Thousand Pesos (₱ 35,000.00)** hereby form the integral part of this resolution. 
