**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
 AND RECOMMENDING APPROVAL OF PROVISION OF FOOD AND
 ACCOMMODATION IN RELATION TO THE 4TH QUARTER AREA MEETING OF
 AREA CENTER 6 AT ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-063-01 for the project **Provision of Food and Accommodation in Relation to the 4th Quarter Area Meeting of Area Center 6 at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Twenty Nine Thousand Five Hundred Pesos (₱ 229,500.00)** for hereby form the integral part of this resolution. WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last December 12, 2023, **GARINFARM AGRITOURISM PARK** was declared Single Calculated Bid with the Bid amount of **Two Hundred Thousand Two Hundred Fifty Pesos (₱200,250.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:


