RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF PROVISION OF FOOD AND ACCOMMODATION IN RELATION TO THE 4TH QUARTER AREA MEETING OF AREA CENTER 6 AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-063-01 for the project Provision of Food and Accommodation in Relation to the 4th Quarter Area Meeting of Area Center 6 at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Two Hundred Twenty Nine Thousand Five Hundred Pesos († 229,500.00) for hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Ouotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last December 12, 2023, GARINFARM AGRITOURISM PARK was declared Single Calculated Bid with the Bid amount of Two Hundred Thousand Two Hundred Fifty Pesos (\$\mathbb{P}200,250.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
