RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF FOOD PROVISION FOR THE YEAR END THANKSGIVING CELEBRATION OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-065-01 for the project Food Provision for the Year End Thanksgiving Celebration of Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of One Hundred Forty Eight Thousand Pesos (P148,000.00) for hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last December 12, 2023, ESCA'S GARDEN RESTAURANT was declared Single Calculated Bid with the Bid amount of One Hundred Forty Seven Thousand Two Hundred Sixty Pesos (*147,260.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
