**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL OF FOOD PROVISION FOR THE YEAR END
THANKSGIVING CELEBRATION OF ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-065-01 for the project **Food Provision for the Year End Thanksgiving Celebration of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Forty Eight Thousand Pesos (P148,000.00)** for hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, during the Bid Opening last December 12, 2023, **ESCA'S GARDEN RESTAURANT** was declared Single Calculated Bid with the Bid amount of **One Hundred Forty Seven Thousand Two Hundred Sixty Pesos (P147,260.00)**;
